A BILL FOR AN ACT

To appropriate the sum of \$44,817.65 for Historical Preservation Office program operations for Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$44,817.65, or so much thereof as
2 may be necessary, is hereby appropriated from the Special
3 Revenue Fund of the State of Yap for the purpose of providing
4 funding to fund Historic Preservation Office operations during
5 Fiscal Year 2026. The sum appropriated shall be deemed from
6 Grant No. P25AF00371-00 and issued by Advice No. 52Y25025.

7 Section 2. Conditions and Restrictions.

8 (1) Funds appropriated by this Act shall not be
9 available for obligation for their planned uses by the agency
10 until the respective grant cash amounts have been drawn down
11 by the State and are deposited in their respective State
12 accounts and available for disbursement.

13 (2) The sum appropriated by this Act shall not be
14 advanced to the agency. Memorandum of agreement (MOA) or
15 other forms of agreement the purpose of which is to obligate
16 and disburse to the agency any amounts from the sum
17 appropriated herein, including reimbursements for payments is
18 prohibited.

1 (3) All funds appropriated by this Act shall be
2 maintained under the authority of the Director of the Office
3 of Administrative Services.

4 Section 3. Allotment and Management of Funds, and
5 Lapse Date. The sum appropriated by this Act shall be
6 allotted to the Governor who shall be responsible for ensuring
7 these funds are used only for the purposes specified under
8 Section 1 of this Act. The sum appropriated by this Act shall
9 be administered in accordance with the provisions of
10 applicable law, including, but not limited to, the State
11 Financial Management Act of 1983 and the State Contracts Act.
12 The authority to obligate the funds appropriated by this Act
13 shall lapse as of September 30, 2027, and any part of this
14 appropriation not obligated as of September 30, 2027 shall
15 revert to the Special Revenue Fund of the State of Yap.

16 Section 4. Reports. The Governor shall submit to the
17 Legislature the performance and financial quarterly reports
18 for each bi-annually in each fiscal year no later than twenty
19 days after the end of the second quarter. Each report shall
20 include, but not limited to, complete descriptions of the
21 obligations incurred against the funds appropriated by this
22 Act, and the status of the Funds as of the end of the
23 completed first two quarters and end of the respective fiscal

1 year.

2 Section 5. This Act shall take effect upon its approval
3 by the Governor, or upon its becoming law without such
4 approval.
