A BILL FOR AN ACT

To appropriate the sum of \$41,242.96 from the Special Revenue Fund of the State of Yap for the purpose of funding the Yap Maternal and Child Health program in the Department of Health Services starting Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$41,242.96, or so much thereof as  
2           may be necessary, is hereby appropriated from the Special  
3           Revenue Fund of the State of Yap for the purpose of providing  
4           funding to fund the Yap Maternal and Child Health program in  
5           the Division of Public Health, Department of Health Services,  
6           starting Fiscal Year 2025. The funds are pursuant to Grant  
7           Award Nos. 1 B04MC54545-01-00/06 and 1 B04MC5454501-  
8           01/02/03/04, which began on October 1, 2024 and ending  
9           September 30, 2026.

10           Section 2. Conditions and Restrictions.

11                   (1) Funds appropriated by this Act shall not be  
12           available for obligation for their planned uses by the agency  
13           until the respective grant cash amounts have been drawn down  
14           by the State and are deposited in their respective State  
15           accounts and available for disbursement.

16                   (2) The sum appropriated by this Act shall not be  
17           advanced to the agency. Memorandum of agreement (MOA) or

1 other forms of agreement the purpose of which is to obligate  
2 and disburse to the agency any amounts from the sum  
3 appropriated herein, including reimbursements for payments is  
4 prohibited.

5 (3) All funds appropriated by this Act shall be  
6 maintained under the authority of the Director of the Office  
7 of Administrative Services.

8 Section 3. Allotment and Management of Funds, and  
9 Lapse Date. The sum appropriated by this Act shall be  
10 allotted to the Governor who shall be responsible for ensuring  
11 these funds are used only for the purposes specified under  
12 Section 1 of this Act. The sum appropriated by this Act shall  
13 be administered in accordance with the provisions of  
14 applicable law, including, but not limited to, the State  
15 Financial Management Act of 1983 and the State Contracts Act.  
16 The authority to obligate the funds appropriated by this Act  
17 shall lapse as of September 30, 2026, and any part of this  
18 appropriation not obligated as of September 30, 2026 shall  
19 revert to the Special Revenue Fund of the State of Yap.

20 Section 4. Reports. The Governor shall submit to the  
21 Legislature the performance and financial quarterly reports  
22 for each quarter in each fiscal year no later than twenty days  
23 after the end of each quarter. Each quarterly report shall  
24 include, but not limited to, complete descriptions of the

1 obligations incurred against the funds appropriated by this  
2 Act, and the status of the Funds as of the end of the  
3 completed quarter.


4 Section 5. This Act shall take effect upon the approval  
5 by the Governor, or upon its becoming law without such  
6 approval.
