FINANCE

A BILL FOR AN ACT

To appropriate the sum of \$104,362.46 from the General Fund of the State of Yap for the purpose of providing additional funding for certain government operations during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$104,362.46, or so much thereof as
2 may be necessary, is hereby appropriated from the WCHC Program
3 Income in the General Fund to providing funding for Waab
4 Community Health Center during Fiscal Year 2026. The sum
5 appropriated shall be apportioned as follows:

- 6 (1) Consumable Expenses \$ 9,512.46; and
7 (2) Contractual Services \$ 94,850.

8 Section 2. Conditions and Restrictions.

9 (1) The sum appropriated by this Act shall not be
10 advanced to any agency. Memorandum of agreement (MOA) or
11 other forms of agreement the purpose of which is to obligate
12 and disburse to the agency any amounts from the sum
13 appropriated herein, including reimbursements for payments is
14 prohibited.

15 (2) All funds appropriated by this Act shall be
16 maintained under the authority of the Director of the Office

1 of Administrative Services.

2 Section 3. Allotment and Management of Funds, and
3 Lapse Date.

4 (1) The sum appropriated by this Act shall be
5 allotted to the Governor, or his designee.

6 (2) The Governor shall be responsible for ensuring
7 these funds are used only for the purpose specified under
8 Section 1 of this Act. The sum appropriated by this Act shall
9 be administered in accordance with the provisions of
10 applicable law, including, but not limited to, the State
11 Financial Management Act of 1983 and the State Contracts Act.
12 The authority to obligate the funds appropriated by this Act
13 shall lapse as of September 30, 2026. Any part of the funds
14 appropriated by this Act not obligated by September 30, 2026
15 shall revert to the General Fund of the State of Yap.

16 Section 4. Reports. The Governor shall submit to the
17 Legislature the performance and financial quarterly reports
18 for each of the quarters in each fiscal year no later than
19 twenty days after the end of each quarter. Each quarterly
20 report shall include, but not limited to, complete
21 descriptions of the obligations incurred against the funds
22 appropriated by this Act, and the status of the funds as of
23 the end of the completed quarter.

24 Section 5. This Act shall take effect upon the approval


1 by the Governor, or upon its becoming law without such
2 approval.
