

AN ACT

To appropriate the sum of \$591,874.24 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for Special Education Program in the Department of Education during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1.   The sum of \$591,874.24, or so much  
2   thereof as may be necessary, is hereby appropriated from  
3   the Special Revenue Fund of the State of Yap for the  
4   purpose of providing funding to fund Special Education  
5   Programs in the Department of Education during Fiscal  
6   Year 2026. The sum appropriated shall be deemed from the  
7   United States Federal Grants identified as Grant Nos.  
8   H027A240005-23A and H027A240005-24A, issued under Advice  
9   of Allotment Nos. 520Y25023 and 520Y25029 and the balance  
10   of funds previously appropriated under Yap State Law Nos.  
11   11-100 and 11-111.

12           Section 2.   Conditions and Restrictions.

13                   (1) Funds appropriated by this Act shall not be  
14   available for obligation for their planned uses by the  
15   agency until the respective grant cash amounts have been  
16   drawn down by the State and are deposited in their  
17   respective State accounts and available for disbursement.

18                   (2) The sum appropriated by this Act shall not

1 be advanced to the agency. Memorandum of agreement (MOA)  
2 or other forms of agreement the purpose of which is to  
3 obligate and disburse to the agency any amounts from the  
4 sum appropriated herein, including reimbursements for  
5 payments is prohibited.

6 (3) All funds appropriated by this Act shall  
7 be maintained under the authority of the Director of the  
8 Office of Administrative Services.

9 Section 3. Allotment and Management of Funds, and  
10 Lapse Date. The sum appropriated by this Act shall be  
11 allotted to the Governor who shall be responsible for  
12 ensuring these funds are used only for the purposes  
13 specified under Section 1 of this Act. The sum  
14 appropriated by this Act shall be administered in  
15 accordance with the provisions of applicable law,  
16 including, but not limited to, the State Financial  
17 Management Act of 1983 and the State Contracts Act. The  
18 authority to obligate the funds appropriated by this Act  
19 shall lapse as of September 30, 2026, and any part of  
20 this appropriation not obligated as of September 30, 2026  
21 shall revert to the Special Revenue Fund of the State of  
22 Yap.

1           Section 4. Reports. The Governor shall submit to  
 2 the Legislature the performance and financial quarterly  
 3 reports for each quarter in each fiscal year no later  
 4 than twenty days after the end of each quarter. Each  
 5 quarterly report shall include, but not limited to,  
 6 complete descriptions of the obligations incurred against  
 7 the funds appropriated by this Act, and the status of  
 8 the funds as of the end of the completed quarter.


9           Section 5. This Act shall take effect upon its  
 10 approval by the Governor, or upon its becoming law  
 11 without such approval.
