

AN ACT

To appropriate the sum of \$111,900 from the General Fund of the State of Yap for the purpose of providing funding to fund certain government fixed assets and accessories during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$111,900, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 General Fund of the State of Yap for the purpose of
4 providing funding to fund certain government fixed assets
5 and accessories for the Department of Public Works and
6 Transportation during Fiscal Year 2025. The sum
7 appropriated shall be apportioned as follows:

- 8 (1) Road and Ground
- 9 Section \$ 13,200; and
- 10 (A) Heavy Duty Tire Changer (\$13,200)
- 11 (2) Yap International
- 12 Airport \$ 98,700.
- 13 (A) Repeater Upgrade (\$9,000)
- 14 (B) Tractor (\$49,700)
- 15 (C) Skid Steer Mulching
- 16 Attachment (\$40,000)

17 Section 2. Conditions and Restrictions.

- 18 (1) The sum appropriated by this Act shall not

1 be advanced to any agency. Memorandum of agreement (MOA)
2 or other forms of agreement the purpose of which is
3 to obligate and disburse to the agency any amounts from
4 the sum appropriated herein, including reimbursements for
5 payments is prohibited.

6 (2) All funds appropriated by this Act shall be
7 maintained under the authority of the Director of the
8 Office of Administrative Services.

9 Section 3. Allotment and Management of Funds, and
10 Lapse Date.

11 (1) The sum appropriated by this Act shall be
12 allotted to the Governor, or his designee.

13 (2) The Governor shall be responsible for
14 ensuring these funds are used only for the purpose
15 specified under Section 1 of this Act. The sum
16 appropriated by this Act shall be administered in
17 accordance with the provisions of applicable law,
18 including, but not limited to, the State Financial
19 Management Act of 1983 and the State Contracts Act. The
20 authority to obligate the funds appropriated by this Act
21 shall lapse as of September 30, 2025. Any part of the
22 funds appropriated by this Act not obligated by September


1 30, 2025 shall revert to the General Fund of the State of
2 Yap.


3 Section 4. Reports. The Governor shall submit to
4 the Legislature the performance and financial quarterly
5 reports for each of the quarters in each fiscal year no
6 later than twenty days after the end of each quarter.
7 Each quarterly report shall include, but not limited to,
8 complete descriptions of the obligations incurred against
9 the funds appropriated by this Act, and the status of
10 the funds as of the end of the completed quarter.

11 Section 5. This Act shall take effect upon the
12 approval by the Governor, or upon its becoming law
13 without such approval.
