Bill No. 11-123

A BILL FOR AN ACT

To appropriate the sum of \$654,778 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for a public health program and Waab Community Health Center with the Department of Health Services during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$654,778, or so much thereof as
2 may be necessary, is hereby appropriated from the Special
3 Revenue Fund of the State of Yap for the purpose of providing
4 funding to fund a public health program and Waab Community
5 Health Center with the Department of Health Services during
6 Fiscal Year 2025. The sum appropriated shall be deemed from
7 United States Federal Grants awarded for health programs as
8 follow:

- 9 (1) Waab Community Health Center
10 Operation Program..... \$ 638,778; and
11 (Grant No. 5 H80CS06653-20-00,
12 expiring on December 31, 2025)
13 (2) FY2025 OPIOD Response (SOR) Program \$ 16,000.
14 (Grant No. 1H79TI087919-01
15 6 NU52PS910242-02-01, expiring on
16 September 30, 2025)

17 Section 2. Conditions and Restrictions.

- 18 (1) Funds appropriated by this Act shall not be

1 available for obligation for their planned uses by the agency
2 until the respective grant cash amounts have been drawn down
3 by the State and are deposited in their respective State
4 accounts and available for disbursement.

5 (2) The sum appropriated by this Act shall not be
6 advanced to the agency. Memorandum of agreement (MOA) or
7 other forms of agreement the purpose of which is to obligate
8 and disburse to the agency any amounts from the sum
9 appropriated herein, including reimbursements for payments is
10 prohibited.

11 (3) All funds appropriated by this Act shall be
12 maintained under the authority of the Director of the Office
13 of Administrative Services.

14 Section 3. Allotment and Management of Funds, and
15 Lapse Date. The sum appropriated by this Act shall be
16 allotted to the Governor who shall be responsible for ensuring
17 these funds are used only for the purposes specified under
18 Section 1 of this Act. The sum appropriated by this Act shall
19 be administered in accordance with the provisions of
20 applicable law, including, but not limited to, the State
21 Financial Management Act of 1983 and the State Contracts Act.
22 The authority to obligate the funds appropriated by this Act
23 shall lapse as of the respective dates as specified under each
24 grant item under Section 1 of this Act, and any part of this


1 appropriation not obligated as of the date specified for each
2 grant under Section 1 shall revert to the Special Revenue Fund
3 of the State of Yap.

4 Section 4. Reports. The Governor shall submit to the
5 Legislature the performance and financial quarterly reports
6 for each quarter in each fiscal year no later than twenty days
7 after the end of each quarter. Each quarterly report shall
8 include, but not limited to, complete descriptions of the
9 obligations incurred against the funds appropriated by this
10 Act, and the status of the funds as of the end of the
11 completed quarter.

12 Section 5. This Act shall take effect upon its approval
13 by the Governor, or upon its becoming law without such
14 approval.
