Bill No. 11-124

A BILL FOR AN ACT

To amend Yap State Law No. 11-29, by amending the Title and Section 1 to appropriate an additional sum of \$17,250 from the Special Revenue Fund of the State of Yap for the Department of Health Services programs during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-29 is  
2 hereby amended to read as follows:

3 "To appropriate the sum of ~~\$248,000~~266,238 from the  
4 Special Revenue Fund of the State of Yap for the purpose of  
5 appropriating U.S. Federal grant funds awarded for Department  
6 of Health programs during Fiscal Year 20245, and for other  
7 purposes."

8 Section 2. Section 1 of Yap State Law No. 11-29 is  
9 hereby amended to read as follows:

10 "Section 1. The sum of ~~\$248,000~~266,238, or so much  
11 thereof as may be necessary, is hereby appropriated from the  
12 Special Revenue Fund of the State of Yap for the purpose of  
13 providing funding to fund Department of Health Services  
14 programs during Fiscal Year 20245. The sum appropriated shall  
15 be deemed from United States Federal Grants awarded for health  
16 programs as follows:

- 1 Treatment (SAPT) Block Grant ..... \$ 79,580;  
2 (Grant No. 1B08T1085814-01/6 B08T1085814-01M003,  
3 expiring September 30, 2024)
- 4 (2) FY2024 Falalop Youth (Yap)  
5 SAPT24 ..... \$ 9,790;  
6 (Grant No. 1B08T1085814-01/6  
7 B08T1085814-01M003, expiring  
8 September 30, 2024)
- 9 (3) FY2024 State OPIOID Response (SOR) ..... \$ 26,000;  
10 (Grant No. 5 H79T1085760-02, expiring  
11 September 29, 2024)
- 12 (4) FY2024 Community Mental Health  
13 Services (CMHS) ..... \$ 45,051;  
14 (Grant No. 1 B09SM087367-01/M001, expiring  
15 September 30, 2024)
- 16 (5) FY2024 Pediatric Mental Health  
17 Care Access (PMHCA) ..... \$ ~~27,250~~44,500; and  
18 (Grant No. 4 U4AMC45816-01-02, expiring  
19 September 29, 2026)
- 20 (6) FY2024 Mother & Child Health (MCH)..... \$ 61,317.  
21 (Grant No. 1 B04MC4715-01/ 6 B04MC47415-01-01/02,  
22 expiring September 30, 2024)“

23 Section 3. This Act shall take effect upon its approval

1 by the Governor, or upon its becoming law without such  
2 approval.


