

AN ACT

To appropriate the sum of \$235,126.10 from the Special Revenue Fund of the State of Yap for the purpose of providing Infrastructure Maintenance Funds (IMF) for certain government repair and renovation projects during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1.   The sum of \$235,126.10, or so much  
2           thereof as may be necessary, is hereby appropriated from  
3           the Special Revenue Fund of the State of Yap, from the  
4           Infrastructure Maintenance Fund (IMF), for the purpose of  
5           providing funding to fund a certain repair and renovation  
6           projects during Fiscal Year 2026. The sum appropriated  
7           shall be apportioned as follows:

8           (1) Government Housing:

9           (a) Quarter No. 43 ..... \$ 113,921.85; and

10          (b) Quarter No. 50 ..... \$    121,204.25.

11          Section 2.   Conditions and Restrictions.

12           (1) Funds appropriated by this Act shall not be  
13           available for obligation for their planned uses by the  
14           agency until the respective grant cash amounts have been  
15           drawn down by the State and are deposited in their  
16           respective State accounts and available for disbursement.

17           (2) The sum appropriated by this Act shall not  
18           be advanced to the agency. Memorandum of agreement (MOA)

1 or other forms of agreement the purpose of which is to  
2 obligate and disburse to the agency any amounts from the  
3 sum appropriated herein, including reimbursements for  
4 payments is prohibited.

5 (3) All funds appropriated by this Act shall  
6 be maintained under the authority of the Director of the  
7 Office of Administrative Services.

8 Section 3. Allotment and Management of Funds, and  
9 Lapse Date. The sum appropriated by this Act shall be  
10 allotted to the Governor who shall be responsible for  
11 ensuring these funds are used only for the purposes  
12 specified under Section 1 of this Act. The sum  
13 appropriated by this Act shall be administered in  
14 accordance with the provisions of applicable law,  
15 including, but not limited to, the State Financial  
16 Management Act of 1983 and the State Contracts Act. The  
17 authority to obligate the funds appropriated by this Act  
18 shall lapse as of September 30, 2026, and any part of  
19 this appropriation not obligated as of September 30, 2026  
20 shall revert to the Special Revenue Fund of the State of  
21 Yap.


22 Section 4. Reports. The Governor shall submit to

1 the Legislature the performance and financial quarterly  
2 reports for each quarter in each fiscal year no later  
3 than twenty days after the end of each quarter. Each  
4 quarterly report shall include, but not limited to,  
5 complete descriptions of the obligations incurred against  
6 the funds appropriated by this Act, and the status of  
7 the funds as of the end of the completed quarter.

8 Section 5. This Act shall take effect upon its  
9 approval by the Governor, or upon its becoming law  
10 without such approval.
