

AN ACT

To appropriate the sum of \$45,600 from the General Fund of the State of Yap for the purpose of providing funding to fund fixed assets for the Department of Public Works and Transportation during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$45,600, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 General Fund of the State of Yap for the purpose of
4 providing funding to fund the purchase of land survey
5 equipment for the Department of Public Works and
6 Transportation during Fiscal Year 2026.

7 Section 2. Conditions and Restrictions.

8 (1) The sum appropriated by this Act shall not
9 be advanced to any agency. Memorandum of agreement (MOA)
10 or other forms of agreement the purpose of which is to
11 obligate and disburse to the agency any amounts from the
12 sum appropriated herein, including reimbursements for
13 payments is prohibited.

14 (2) All funds appropriated by this Act shall be
15 maintained under the authority of the Director of the
16 Office of Administrative Services.

17 Section 3. Allotment and Management of Funds, and
18 Lapse Date.

1 (1) The sum appropriated by this Act shall be
2 allotted to the Governor, or his designee.

3 (2) The Governor shall be responsible for
4 ensuring these funds are used only for the purpose
5 specified under Section 1 of this Act. The sum
6 appropriated by this Act shall be administered in
7 accordance with the provisions of applicable law,
8 including, but not limited to, the State Financial
9 Management Act of 1983 and the State Contracts Act. The
10 authority to obligate the funds appropriated by this Act
11 shall lapse as of September 30, 2026. Any part of the
12 funds appropriated by this Act not obligated by September
13 30, 2026 shall revert to the General Fund of the State of
14 Yap.

15 Section 4. Reports. The Governor shall submit to
16 the Legislature the performance and financial quarterly
17 reports for each quarter in each fiscal year no later
18 than twenty days after the end of each quarter. Each
19 quarterly report shall include, but not limited to,
20 complete descriptions of the obligations incurred against
21 the funds appropriated by this Act, and the status of
22 the Funds as of the end of the completed quarter.

1 Section 5. This Act shall take effect upon the
2 approval by the Governor, or upon its becoming law
3 without such approval.
