

AN ACT

To amend Yap State Law No. 11-130, FY2026 General Fund Budget, by amending the Title and Section 1 to appropriate the additional sum of \$287,047 from the Yap State Fiscal Year 2026 financial estimates in General Fund for the purpose of making corrections to the funding of government operations, programs and projects in the State of Yap during Fiscal Year 2026, by amending Section 4 to re-instate quarterly reporting requirements, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-130 is
2 hereby amended to read as follows:

3 “To appropriate the sum of \$11,865,035 from the Yap
4 State Fiscal Year 2026 financial estimates in the
5 General Fund for the purpose of funding government
6 operations, programs and projects in the State of
7 Yap during Fiscal Year 2026, and for other
8 purposes.”

9 Section 2. Section 1 of Yap State Law No. 11-130 is
10 hereby amended to read as follows:

11 “Section 1. Operations, Programs and Projects. The
12 sum of \$11,865,035, or so much thereof as may be
13 necessary, is hereby appropriated from the General Fund
14 for the purpose of funding government operations,
15 programs and projects during Fiscal Year 2026. The sum
16 appropriated shall be from Local Revenues for

1 \$10,219,828, from Program Income for \$816,042, from
2 Airport and Airway Operation and Maintenance Account for
3 \$129,165, and from the General Fund Tobacco Tax account
4 for \$700,000; and shall be apportioned in accordance with
5 the following schedule:

13 Section 3. Section 4 of Yap State Law No. 11-130 is
14 hereby amended to read as follows:

15 “Section 4. Reports. The Governor shall submit to
16 the Legislature the performance and financial quarterly
17 reports for each quarter in Fiscal Year 2026 no later
18 than twenty days after the end of each quarter. Each
19 quarterly report shall include, but not limited to,
20 complete descriptions of the obligations incurred against
21 the funds appropriated by this Act, and the status of the
22 funds as of the end of the completed quarter.”

1 Section 4. This Act shall become effective on
2 October 01, 2025 upon the approval by the Governor, or
3 upon its becoming law without such approval.
