

AN ACT

To appropriate the sum of \$44,817.65 for Historical Preservation Office program operations for Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$44,817.65, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the Special Revenue Fund of the State of Yap for the
4 purpose of providing funding to fund Historic
5 Preservation Office operations during Fiscal Year 2026.
6 The sum appropriated shall be deemed from Grant No.
7 P25AF00371-00 and issued by Advice No. 52Y25025.

8 Section 2. Conditions and Restrictions.

9 (1) Funds appropriated by this Act shall not be
10 available for obligation for their planned uses by the
11 agency until the respective grant cash amounts have been
12 drawn down by the State and are deposited in their
13 respective State accounts and available for disbursement.

14 (2) The sum appropriated by this Act shall not
15 be advanced to the agency. Memorandum of agreement (MOA)
16 or other forms of agreement the purpose of which is to
17 obligate and disburse to the agency any amounts from the
18 sum appropriated herein, including reimbursements for

1 payments is prohibited.

2 (3) All funds appropriated by this Act shall
3 be maintained under the authority of the Director of the
4 Office of Administrative Services.

5 Section 3. Allotment and Management of Funds, and
6 Lapse Date. The sum appropriated by this Act shall be
7 allotted to the Governor who shall be responsible for
8 ensuring these funds are used only for the purposes
9 specified under Section 1 of this Act. The sum
10 appropriated by this Act shall be administered in
11 accordance with the provisions of applicable law,
12 including, but not limited to, the State Financial
13 Management Act of 1983 and the State Contracts Act. The
14 authority to obligate the funds appropriated by this Act
15 shall lapse as of September 30, 2027, and any part of
16 this appropriation not obligated as of September 30, 2027
17 shall revert to the Special Revenue Fund of the State of
18 Yap.

19 Section 4. Reports. The Governor shall submit to
20 the Legislature the performance and financial quarterly
21 reports for each bi-annually in each fiscal year no later
22 than twenty days after the end of the second quarter.

1 Each report shall include, but not limited to, complete
 2 descriptions of the obligations incurred against the
 3 funds appropriated by this Act, and the status of the
 4 Funds as of the end of the completed first two quarters
 5 and end of the respective fiscal year.

6 Section 5. This Act shall take effect upon its
 7 approval by the Governor, or upon its becoming law
 8 without such approval.
