

AN ACT

To appropriate the sum of \$106,693 from the Special Revenue Fund of the State of Yap for the purpose of funding the Immunization program in the Department of Health Services, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$106,693, or so much thereof  
2           as may be necessary, is hereby appropriated from the  
3           Special Revenue Fund of the State of Yap for the purpose  
4           of providing funding to fund the Immunization and  
5           Vaccines for Children program in the Division of Public  
6           Health, Department of Health Services during Fiscal Year  
7           2025. The funds are pursuant to Grant Award No. 1  
8           NH231ip922682-01-00, which started on July 1, 2025 and  
9           ending June 30, 2026.

10           Section 2. Conditions and Restrictions.

11                   (1) Funds appropriated by this Act shall not be  
12           available for obligation for their planned uses by the  
13           agency until the respective grant cash amounts have been  
14           drawn down by the State and are deposited in their  
15           respective State accounts and available for disbursement.

16                   (2) The sum appropriated by this Act shall not  
17           be advanced to the agency. Memorandum of agreement (MOA)  
18           or other forms of agreement the purpose of which

1 is to obligate and disburse to the agency any amounts  
2 from the sum appropriated herein, including  
3 reimbursements for payments is prohibited.

4 (3) All funds appropriated by this Act shall  
5 be maintained under the authority of the Director of the  
6 Office of Administrative Services.

7 Section 3. Allotment and Management of Funds, and  
8 Lapse Date. The sum appropriated by this Act shall be  
9 allotted to the Governor who shall be responsible for  
10 ensuring these funds are used only for the purposes  
11 specified under Section 1 of this Act. The sum  
12 appropriated by this Act shall be administered in  
13 accordance with the provisions of applicable law,  
14 including, but not limited to, the State Financial  
15 Management Act of 1983 and the State Contracts Act. The  
16 authority to obligate the funds appropriated by this Act  
17 shall lapse as of June 30, 2026, and any part of this  
18 appropriation not obligated as of June 30, 2026 shall  
19 revert to the Special Revenue Fund of the State of Yap.

20 Section 4. Reports. The Governor shall submit to  
21 the Legislature the performance and financial quarterly  
22 reports for each quarter in each fiscal year no later


1 than twenty days after the end of each quarter. Each  
2 quarterly report shall include, but not limited to,  
3 complete descriptions of the obligations incurred against  
4 the funds appropriated by this Act, and the status of  
5 the Funds as of the end of the completed quarter.

6 Section 5. This Act shall take effect upon the  
7 approval by the Governor, or upon its becoming law  
8 without such approval.
