

AN ACT

To appropriate the sum of \$80,000 from the General Fund of the State of Yap for the purpose of providing funding to fund the updating and publication of the Yap State Code, for the initiation of the Yap State Code Commission account in Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$80,000, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 General Fund of the State of Yap for the purpose of
4 providing funding to fund the updating and publication of
5 the Yap State Code during Fiscal Year 2026 and to further
6 initiate the re-establishment of the Yap State Code
7 Commission account within the Yap State Treasury.

8 Section 2. The sum appropriated by this Act shall
9 be maintained under the authority of the Director of the
10 Office of Administrative Services.

11 Section 3. (1) The sum appropriated by this Act
12 shall be allotted to the Governor.

13 (2) The Governor shall be responsible for
14 ensuring these funds are used only for the purpose
15 specified under Section 1 of this Act. The sum
16 appropriated by this Act shall be administered in
17 accordance with the provisions of applicable law,
18 including, but not limited to, the State Financial

1 Management Act of 1983 and the State Contracts Act. The
2 authority to obligate the funds appropriated by this Act
3 shall lapse as of September 30, 2026. Any part of this
4 appropriation not obligated as of September 30, 2026
5 shall revert to the General Fund of the State of Yap.

6 Section 4. The Governor shall submit to the
7 Legislature the performance and financial quarterly
8 reports for each of the quarters in the fiscal year no
9 later than twenty days after the end of each quarter.
10 Each quarterly report shall include, but not limited to,
11 complete descriptions of the obligations incurred against
12 the funds appropriated by this Act, and the status of
13 the Funds as of the end of the completed quarter.

14 Section 5. There is hereby established a Yap State
15 Code Commission Account within the Enterprise Fund in the
16 Treasury of the State of Yap where proceeds from the sale
17 of the Yap State Code and any other funds available for
18 the purpose of updating the Code shall be accounted for
19 and used in accordance to applicable statute.


20 Section 6. This Act shall take effect upon the
