

AN ACT

To appropriate the sum of \$104,362.46 from the General Fund of the State of Yap for the purpose of providing additional funding for certain government operations during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$104,362.46, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the WCHC Program Income in the General Fund to providing
4 funding for Waab Community Health Center during Fiscal
5 Year 2026. The sum appropriated shall be apportioned as
6 follows:

- 7 (1) Consumable Expenses \$ 9,512.46;
8 and
9 (2) Contractual Services \$ 94,850.

10 Section 2. Conditions and Restrictions.

11 (1) The sum appropriated by this Act shall not
12 be advanced to any agency. Memorandum of agreement (MOA)
13 or other forms of agreement the purpose of which is to
14 obligate and disburse to the agency any amounts from the
15 sum appropriated herein, including reimbursements for
16 payments is prohibited.

17 (2) All funds appropriated by this Act shall be
18 maintained under the authority of the Director of the

1 Office of Administrative Services.

2 Section 3. Allotment and Management of Funds, and
3 Lapse Date.

4 (1) The sum appropriated by this Act shall be
5 allotted to the Governor, or his designee.

6 (2) The Governor shall be responsible for
7 ensuring these funds are used only for the purpose
8 specified under Section 1 of this Act. The sum
9 appropriated by this Act shall be administered in
10 accordance with the provisions of applicable law,
11 including, but not limited to, the State Financial
12 Management Act of 1983 and the State Contracts Act. The
13 authority to obligate the funds appropriated by this Act
14 shall lapse as of September 30, 2026. Any part of the
15 funds appropriated by this Act not obligated by September
16 30, 2026 shall revert to the General Fund of the State of
17 Yap.

18 Section 4. Reports. The Governor shall submit to
19 the Legislature the performance and financial quarterly
20 reports for each of the quarters in each fiscal year no
21 later than twenty days after the end of each quarter.
22 Each quarterly report shall include, but not limited to,

1 complete descriptions of the obligations incurred against
2 the funds appropriated by this Act, and the status of
3 the funds as of the end of the completed quarter.


4 Section 5. This Act shall take effect upon the
5 approval by the Governor, or upon its becoming law
6 without such approval.
