YAP STATE LAW NO. 11-145

THIRD REGULAR SESSION, 2025

AN ACT

To appropriate the sum of \$41,242.96 from the Special Revenue Fund of the State of Yap for the purpose of funding the Yap Maternal and Child Health program in the Department of Health Services starting Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$41,242.96, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the Special Revenue Fund of the State of Yap for the
4 purpose of providing funding to fund the Yap Maternal and
5 Child Health program in the Division of Public Health,
6 Department of Health Services, starting Fiscal Year 2025.
7 The funds are pursuant to Grant Award Nos. 1 B04MC54545-
8 01-00 and 6 B04MC54545-01-01/02/03/04, which began on
9 October 1, 2024 and ending September 30, 2026.

10 Section 2. Conditions and Restrictions.

11 (1) Funds appropriated by this Act shall not be
12 available for obligation for their planned uses by the
13 agency until the respective grant cash amounts have been
14 drawn down by the State and are deposited in their
15 respective State accounts and available for disbursement.

16 (2) The sum appropriated by this Act shall not
17 be advanced to the agency. Memorandum of agreement (MOA)
18 or other forms of agreement the purpose of which is to

1 appropriated herein, including reimbursements for
2 payments is prohibited.

3 (3) All funds appropriated by this Act shall
4 be maintained under the authority of the Director of the
5 Office of Administrative Services.

6 Section 3. Allotment and Management of Funds, and
7 Lapse Date. The sum appropriated by this Act shall be
8 allotted to the Governor who shall be responsible for
9 ensuring these funds are used only for the purposes
10 specified under Section 1 of this Act. The sum
11 appropriated by this Act shall be administered in
12 accordance with the provisions of applicable law,
13 including, but not limited to, the State Financial
14 Management Act of 1983 and the State Contracts Act. The
15 authority to obligate the funds appropriated by this Act
16 shall lapse as of September 30, 2026, and any part of
17 this appropriation not obligated as of September 30, 2026
18 shall revert to the Special Revenue Fund of the State of
19 Yap.

20 Section 4. Reports. The Governor shall submit to
21 the Legislature the performance and financial quarterly
22 reports for each quarter in each fiscal year no later

1 than twenty days after the end of each quarter. Each
2 quarterly report shall include, but not limited to,
3 complete descriptions of the obligations incurred against
4 the funds appropriated by this Act, and the status of
5 the Funds as of the end of the completed quarter.


6 Section 5. This Act shall take effect upon the
7 approval by the Governor, or upon its becoming law
8 without such approval.
