

AN ACT

To appropriate the sum of \$26,438 from the General Fund of the State of Yap for the purpose of providing funding to fund the Autopsy Account during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$26,438, or so much thereof  
2           as may be necessary, is hereby appropriated from the  
3           General Fund of the State of Yap for the purpose of  
4           providing funding to fund the Autopsy Account under the  
5           administration of the Office of the Attorney General  
6           during Fiscal Year 2025. The funds shall be apportioned  
7           as follows:

- 8                     (1) Autopsy account ..... \$ 18,438; and
- 9                     (2) Morgue fees ..... \$ 8,000.

10           Section 2. Conditions and Restrictions.

11                     (1) The sum appropriated by this Act shall not  
12           be advanced to any agency. Memorandum of agreement (MOA)  
13           or other forms of agreement the purpose of which is to  
14           obligate and disburse to the agency any amounts from the  
15           sum appropriated herein, including reimbursements for  
16           payments is prohibited.

17                     (2) All funds appropriated by this Act shall be  
18           maintained under the authority of the Director of the

1 Office of Administrative Services.

2 Section 3. Allotment and Management of Funds, and  
3 Lapse Date.

4 (1) The sum appropriated by this Act shall  
5 be allotted to the Governor, or his designee.

6 (2) The allottee shall be responsible for  
7 ensuring these funds are used only for the purpose  
8 specified under Section 1 of this Act. The sum  
9 appropriated by this Act shall be administered in  
10 accordance with the provisions of applicable law,  
11 including, but not limited to, the State Financial  
12 Management Act of 1983 and the State Contracts Act. The  
13 authority to obligate the funds appropriated by this Act  
14 shall not lapse.


15 Section 4. Reports. The allottee shall submit to  
16 the Legislature the performance and financial quarterly  
17 reports for each of the quarters in each fiscal year no  
18 later than twenty days after the end of each quarter.  
19 Each quarterly report shall include, but not limited to,  
20 complete descriptions of the obligations incurred against  
21 the funds appropriated by this Act, and the status of  
22 the Funds as of the end of the completed quarter.

1 Section 5. This Act shall take effect upon the  
2 approval by the Governor, or upon its becoming law  
3 without such approval.
