

AN ACT

To appropriate the sum of \$45,620 from the General Fund of the State of Yap for the purpose of providing funding to fund activities and programs relating to the 2025 Yap Day Celebration during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$45,620, or so much thereof  
2           as may be necessary, is hereby appropriated from the  
3           General Fund of the State of Yap for the purpose of  
4           providing funding to fund activities and programs related  
5           to the 2025 Yap Day Celebration during Fiscal Year 2025.

6           Section 2. Conditions and Restrictions.

7                   (1) The sum appropriated by this Act shall not  
8           be advanced to any agency. Memorandum of agreement  
9           (MOA) or other forms of agreement the purpose of  
10          which is to obligate and disburse to the agency any  
11          amounts from the sum appropriated herein, including  
12          reimbursements for payments is prohibited.

13                   (2) All funds appropriated by this Act shall be  
14          maintained under the authority of the Director of the  
15          Office of Administrative Services.

16          Section 3. Allotment and Management of Funds, and  
17          Lapse Date.

18                   (1) The sum appropriated by this Act shall be

1       allotted to the Governor, or his designee.

2               (2) The Governor shall be responsible for  
3 ensuring these funds are used only for the purpose  
4 specified under       Section 1 of this Act. The sum  
5 appropriated by this Act shall be administered in  
6 accordance with the provisions of applicable law,  
7 including, but not limited to, the State Financial  
8 Management Act of 1983. The authority to obligate the  
9 funds appropriated by this Act shall lapse as of  
10 September 30, 2025. Any part of the funds appropriated  
11 by this Act not obligated by September 30, 2025 shall  
12 revert to the General Fund of the State of Yap.


13       Section 4. Reports. The Governor shall ensure  
14 submission to the Legislature the performance and  
15 financial report, including revision to the Yap Day Plan,  
16 pursuant to the requirements in Section 802 of Title 1 in  
17 the Yap Day Code for the Yap Day Committee. The report  
18 shall be submitted no later than 30 days after the  
19 conclusion of Yap Day Celebration.

20       Section 5. This Act shall take effect upon the  
21 approval by the Governor, or upon its becoming law  
22 without such approval.
