

AN ACT

To appropriate the sum of \$43,913.50 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for public health programs with the Department of Health Services during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$43,913.50, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the Special Revenue Fund of the State of Yap for the
4 purpose of providing funding to fund public health
5 programs with the Department of Health Services during
6 Fiscal Year 2025. The sum appropriated shall be deemed
7 from United States Federal Grants awarded for health
8 programs as follow:

- 9 (1) FY2025 Yap HIV/AIDS Prevention
10 Program..... \$ 21,766;
11 (Grant No. 5 NU52PS910242-03-00, expiring on
12 December 31, 2025)
- 13 (2) FY2025 TB Program..... \$ 16,600;
14 and (Grant No. 5 NU52PS910242-03-00, expiring
15 on December 31, 2025)
- 16 (3) FY2024 Yap State Development
17 Initiative (SSDI) \$ 5,547.50.
18 (Grant No. 5 H18MC00060-32-00, expiring on

1 November 30, 2025)

2 Section 2. Conditions and Restrictions.

3 (1) Funds appropriated by this Act shall not be
4 available for obligation for their planned uses by the
5 agency until the respective grant cash amounts have been
6 drawn down by the State and are deposited in their
7 respective State accounts and available for disbursement.

8 (2) The sum appropriated by this Act shall not
9 be advanced to the agency. Memorandum of agreement (MOA)
10 or other forms of agreement the purpose of which is to
11 obligate and disburse to the agency any amounts from the
12 sum appropriated herein, including reimbursements for
13 payments is prohibited.

14 (3) All funds appropriated by this Act shall
15 be maintained under the authority of the Director of the
16 Office of Administrative Services.

17 Section 3. Allotment and Management of Funds, and
18 Lapse Date. The sum appropriated by this Act shall be
19 allotted to the Governor who shall be responsible for
20 ensuring these funds are used only for the purposes
21 specified under Section 1 of this Act. The sum
22 appropriated by this Act shall be administered in

1 accordance with the provisions of applicable law,
2 including, but not limited to, the State Financial
3 Management Act of 1983 and the State Contracts Act. The
4 authority to obligate the funds appropriated by this Act
5 shall lapse as of the respective dates as specified under
6 each grant item under Section 1 of this Act, and any part
7 of this appropriation not obligated as of the date
8 specified for each grant under Section 1 shall revert to
9 the Special Revenue Fund of the State of Yap.

10 Section 4. Reports. The Governor shall submit to
11 the Legislature the performance and financial quarterly
12 reports for each quarter in each fiscal year no later
13 than twenty days after the end of each quarter. Each
14 quarterly report shall include, but not limited to,
15 complete descriptions of the obligations incurred against
16 the funds appropriated by this Act, and the status of
17 the funds as of the end of the completed quarter.

18 Section 5. This Act shall take effect upon its
19 approval by the Governor, or upon its becoming law
20 without such approval.
