

AN ACT

To appropriate the sum of \$141,042.71 from the Special Revenue Fund of the State of Yap for the purpose of providing Infrastructure Maintenance Funds (IMF) for certain government repair and renovation projects during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$141,042.71, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the Special Revenue Fund of the State of Yap, from the
4 Infrastructure Maintenance Fund (IMF), for the purpose of
5 providing funding to fund a certain repair and renovation
6 projects during Fiscal Year 2025. The sum appropriated
7 shall be apportioned as follows:

8 (1) Yap State Legislature:

9 (a) Electrical Wiring and Overhaul . \$ 36,438;

10 (2) Office of Administrative Services

11 (a) Archives Building

12 Repair/Rehab \$ 64,592.84;

13 and

14 (b) Exec. Building Comfort Room

15 Repair/Rehab \$ 40,011.87.

16 Section 2. Conditions and Restrictions.

17 (1) Funds appropriated by this Act shall not be
18 available for obligation for their planned uses by the

1 agency until the respective grant cash amounts have been
2 drawn down by the State and are deposited in their
3 respective State accounts and available for disbursement.

4 (2) The sum appropriated by this Act shall not
5 be advanced to the agency. Memorandum of agreement (MOA)
6 or other forms of agreement the purpose of which is to
7 obligate and disburse to the agency any amounts from the
8 sum appropriated herein, including reimbursements for
9 payments is prohibited.

10 (3) All funds appropriated by this Act shall
11 be maintained under the authority of the Director of the
12 Office of Administrative Services.

13 Section 3. Allotment and Management of Funds, and
14 Lapse Date. The sum appropriated by this Act shall be
15 allotted to the Governor who shall be responsible for
16 ensuring these funds are used only for the purposes
17 specified under Section 1 of this Act. The sum
18 appropriated by this Act shall be administered in
19 accordance with the provisions of applicable law,
20 including, but not limited to, the State Financial
21 Management Act of 1983 and the State Contracts Act. The
22 authority to obligate the funds appropriated by this Act

1 shall lapse as of September 30, 2025, and any part of
2 this appropriation not obligated as of September 30, 2025.
3 shall revert to the Special Revenue Fund of the State of
4 Yap.

5 Section 4. Reports. The Governor shall submit to
6 the Legislature the performance and financial quarterly
7 reports for each quarter in each fiscal year no later
8 than twenty days after the end of each quarter. Each
9 quarterly report shall include, but not limited to,
10 complete descriptions of the obligations incurred against
11 the funds appropriated by this Act, and the status of
12 the funds as of the end of the completed quarter.

13 Section 5. This Act shall take effect upon its
14 approval by the Governor, or upon its becoming law
15 without such approval.


