Resolution No. 11-114

A RESOLUTION

Approving \$14,486,720, subject to Yap State appropriation law, the Yap State Fiscal Year 2026 recommended budget estimates for funding under the 2023 Amended Compact for submission to the President of the Federated States of Micronesia to transmit to the United States for review and approval.

1 BE IT RESOLVED by the Eleventh Legislature of the State of
2 Yap, Third Regular Session, 2025 that the Legislature hereby
3 approves \$14,486,720, subject to Yap State appropriation law,
4 the Yap State Fiscal Year 2026 recommended budget estimates for
5 funding under the 2023 Amended Compact for submission to the
6 President of the Federated States of Micronesia to transmit to
7 the United States for review and approval; and

8 BE IT FURTHER RESOLVED the \$14,486,720 breakdown by sources
9 are as follows:

- 10 1. Education sector \$7,344,594,
- 11 2. Health Sector \$6,476,841,
- 12 3. Public Sector \$268,409, and
- 13 5. Enhanced Rep. & Accty \$396,876; and

14 BE IT FURTHER RESOLVED that the Governor shall timely
15 inform the Legislature of the 2023 Amended Compact sector grant
16 awards for funding the Fiscal Year 2026 Budget, and to provide
17 all pertinent information such as specific changes made by the
18 United States to the budget details as recommended by the
19 Legislature, and any condition which the United States may have

1 imposed on any planned uses of the grants awarded for Yap State;
2 and


3 BE IT FURTHER RESOLVED that the Legislature endorses and
4 approves the Yap State Project Management Office operation
5 budget of \$723,219 for Fiscal Year 2026, subject to
6 Congressional appropriation; and

7 BE IT FURTHER RESOLVED that this Legislature endorses
8 application for \$1,998,979 to be drawn down from the FSM Trust
9 Fund, Account 3, for use by Yap State for the purpose of funding
10 purchase of needed port equipment; and


11 BE IT FURTHER RESOLVED that certified copies of this

13 Federated States of Micronesia, the Director of the Office of
14 Planning and Budget, the Director of the Office of
