Bill No. 11-193¹

A BILL FOR AN ACT

To appropriate the sum of \$50,000 from the Special Revenue Fund of the State of Yap for the purpose of providing funding to authorize the Embassy of the People's Republic of China Grant for Ifalik Water Catchment during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$50,000, or so much thereof as may
2 be necessary, is hereby appropriated from the Special Revenue
3 Fund of the State of Yap for the purpose of providing funding
4 to authorize the use of the grant funds from the Embassy of
5 the People's Republic of China for the water catchment project
6 in Ifalik Atoll during Fiscal Year 2026. The sum appropriated
7 shall be deemed the grant funds deposited into the Yap State
8 Treasury on December 18, 2025 as per check number 4476.

9 Section 2. Conditions and Restrictions. The sum
10 appropriated by this Act shall not be advanced to the agency.
11 Memorandum of agreement (MOA) or other forms of agreement the
12 purpose of which is to obligate and disburse to the agency any
13 amounts from the sum appropriated herein, including
14 reimbursements for payments is prohibited. All funds
15 appropriated by this Act shall be maintained under the
16 authority of the Director of the Office of Administrative

1 Services.

2 Section 3. Allotment and Management of Funds, and
3 Lapse Date.

4 (1) The sum appropriated by this Act shall be
5 allotted to the Governor.

6 (2) The Governor shall be responsible for ensuring
7 these funds are used only for the purpose specified under
8 Section 1 of this Act. The sum appropriated by this Act shall
9 be administered in accordance with the provisions of
10 applicable law, including, but not limited to, the State
11 Financial Management Act of 1983 and the State Contracts Act.
12 The authority to obligate the funds appropriated by this Act
13 shall lapse as of September 30, 2026. Any part of this
14 appropriation not obligated as of September 30, 2026 shall
15 revert to the Special Revenue Fund of the State of Yap.

16 Section 4. Reports. The Governor shall submit to the
17 Legislature the performance and financial quarterly reports
18 for each of the quarters in each fiscal year no later than
19 twenty days after the end of each quarter. Each quarterly
20 report shall include, but not limited to, complete
21 descriptions of the obligations incurred against the funds
22 appropriated by this Act, and the status of the Funds as of
23 the end of the completed quarter.

24 Section 5. This Act shall take effect upon the approval

1 by the Governor, or upon its becoming law without such
2 approval.
