Bill No. 11-212¹

A BILL FOR AN ACT

To amend Yap State Law No. 11-151, by amending the Title and Section 1 to further appropriate the additional sum of \$131,887 from the Special Revenue Fund of the State of Yap for the purpose of providing further funding to Special Education program operations in the Department of Education during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-151 is
2 hereby amended to read as follows:

3 “To appropriate the sum of ~~\$\$\$1,874,247~~23,761.24 from the
4 Special Revenue Fund of the State of Yap for the purpose
5 of appropriating U.S. Federal grant funds awarded for
6 Special Education Program in the Department of Education
7 during Fiscal Year 2026, and for other purposes.”

8 Section 2. Section 1 of Yap State Law No. 11-151 is
9 hereby amended to read as follows:

10 “Section 1. The sum of ~~\$\$\$1,874,247~~23,761.24, or so much
11 thereof as may be necessary, is hereby appropriated from the
12 Special Revenue Fund of the State of Yap for the purpose of
13 providing funding to fund Special Education Programs in the
14 Department of Education during Fiscal Year 2026. The sum
15 appropriated shall be deemed from the United States Federal
16 Grants identified as Grant Nos. H027A240005-23A and

1 H027A240005-24A, issued under Advice of Allotment Nos.
2 520Y25023, ~~and 520Y25029,~~ and 520Y26003 and the balance of
3 funds previously appropriated under Yap State Law Nos. 11-100
4 and 11-111."


5 Section 3. Section 3 of Yap State Law No. 11-151 is
6 hereby amended to read as follows:

7 "Section 3. Allotment and Management of Funds, and
8 Lapse Date. The sum appropriated by this Act shall be
9 allotted to the Governor who shall be responsible for ensuring
10 these funds are used only for the purposes specified under
11 Section 1 of this Act. The sum appropriated by this Act shall
12 be administered in accordance with the provisions of
13 applicable law, including, but not limited to, the State
14 Financial Management Act of 1983 and the State Contracts Act.
15 The authority to obligate the funds appropriated by this Act
16 shall lapse as of ~~December 31~~ September 30, 2026, and any part
17 of this appropriation not obligated as of ~~December 31~~ September
18 30, 2026 shall revert to the Special Revenue Fund of the State
19 of Yap."

20 Section 4. This Act shall take effect upon the approval
21 by the Governor, or upon its becoming law without such
22 approval.
