A BILL FOR AN ACT

To appropriate the sum of \$260,000 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for Special Education Program in the Department of Education during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$260,000, or so much thereof as
2 may be necessary, is hereby appropriated from the Special
3 Revenue Fund of the State of Yap for the purpose of providing
4 funding to fund Special Education Programs in the Department
5 of Education during Fiscal Year 2026. The sum appropriated
6 shall be deemed from the United States Federal Grants
7 identified as Grant Nos. H027A250005 and H027A250005-25A,
8 issued under Advice of Allotment No. 520Y26005.

9 Section 2. Conditions and Restrictions.

10 (1) Funds appropriated by this Act shall not be
11 available for obligation for their planned uses by the agency
12 until the respective grant cash amounts have been drawn down
13 by the State and are deposited in their respective State
14 accounts and available for disbursement.

15 (2) The sum appropriated by this Act shall not be

1 advanced to the agency. Memorandum of agreement (MOA) or
2 other forms of agreement the purpose of which is to obligate
3 and disburse to the agency any amounts from the sum
4 appropriated herein, including reimbursements for payments is
5 prohibited.

6 (3) All funds appropriated by this Act shall be
7 maintained under the authority of the Director of the Office
8 of Administrative Services.

9 Section 3. Allotment and Management of Funds, and
10 Lapse Date. The sum appropriated by this Act shall be
11 allotted to the Governor who shall be responsible for ensuring
12 these funds are used only for the purposes specified under
13 Section 1 of this Act. The sum appropriated by this Act shall
14 be administered in accordance with the provisions of
15 applicable law, including, but not limited to, the State
16 Financial Management Act of 1983 and the State Contracts Act.
17 The authority to obligate the funds appropriated by this Act
18 shall lapse as of September 30, 2026, and any part of this
19 appropriation not obligated as of September 30, 2026 shall
20 revert to the Special Revenue Fund of the State of Yap.

21 Section 4. Reports. The Governor shall submit to the
22 Legislature the performance and financial quarterly reports
23 for each quarter in each fiscal year no later than twenty days

1 after the end of each quarter. Each quarterly report shall
2 include, but not limited to, complete descriptions of the
3 obligations incurred against the funds appropriated by this
4 Act, and the status of the Funds as of the end of the
5 completed quarter.

6 Section 5. This Act shall take effect upon the approval
7 by the Governor, or upon its becoming law without such
8 approval.
