

AN ACT

To appropriate the sum of \$137,786 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for public health programs with the Department of Health Services during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$137,786, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to fund public health programs with
5 the Department of Health Services during Fiscal Year
6 2026. The sum appropriated shall be deemed from United
7 States Federal Grants awarded for health programs as
8 follow:

- 9 (1) FY2026 Substance Abuse Prevention
- 10 Treatment (SAPT)
- 11 Program \$ 82,570; and
- 12 (Grant No. 1 B08T1088113-01/1
- 13 B08T1088113-01-REVISED,
- 14 expiring on September 30, 2026)
- 15 (2) FY 2026 Community Mental Health
- 16 Services (CMHS)
- 17 Program \$ 55,216.
- 18 (Grant No. 1 B09SM090350-01/1

1 BO9SM090350-01 REVISED,
2 expiring on September 30, 2026)
3 Section 2. Conditions and Restrictions.

4 (1) Funds appropriated by this Act shall not be
5 available for obligation for their planned uses by the
6 agency until the respective grant cash amounts have been
7 drawn down by the State and are deposited in their
8 respective State accounts and available for disbursement.

9 (2) The sum appropriated by this Act shall not
10 be advanced to the agency. Memorandum of agreement (MOA)
11 or other forms of agreement the purpose of which is to
12 obligate and disburse to the agency any amounts from the
13 sum appropriated herein, including reimbursements for
14 payments is prohibited.

15 (3) All funds appropriated by this Act shall
16 be maintained under the authority of the Director of the
17 Office of Administrative Services.

18 Section 3. Allotment and Management of Funds, and
19 Lapse Date. The sum appropriated by this Act shall be
20 allotted to the Governor who shall be responsible for
21 ensuring these funds are used only for the purposes
22 specified under Section 1 of this Act. The sum

1 appropriated by this Act shall be administered in
2 accordance with the provisions of applicable law,
3 including, but not limited to, the State Financial
4 Management Act of 1983 and the State Contracts Act. The
5 authority to obligate the funds appropriated by this Act
6 shall lapse as of the respective dates as specified under
7 each grant item under Section 1 of this Act, and any part
8 of this appropriation not obligated as of the date
9 specified for each grant under Section 1 shall revert to
10 the Special Revenue Fund of the State of Yap.

11 Section 4. Reports. The Governor shall submit to
12 the Legislature the performance and financial quarterly
13 reports for each quarter in each fiscal year no later
14 than twenty days after the end of each quarter. Each
15 quarterly report shall include, but not limited to,
16 complete descriptions of the obligations incurred against
17 the funds appropriated by this Act, and the status of
18 the funds as of the end of the completed quarter.


19 Section 5. This Act shall take effect upon its
20 approval by the Governor, or upon its becoming law
21 without such approval.
