

AN ACT

To appropriate the sum of \$50,000 from the Special Revenue Fund of the State of Yap for the purpose of providing funding to authorize the Embassy of the People's Republic of China Grant for Ifalik Water Catchment during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$50,000, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to authorize the use of the grant
5 funds from the Embassy of the People's Republic of China
6 for the water catchment project in Ifalik Atoll during
7 Fiscal Year 2026. The sum appropriated shall be deemed
8 the grant funds deposited into the Yap State Treasury on
9 December 18, 2025 as per check number 4476.

10 Section 2. Conditions and Restrictions. The sum.
11 appropriated by this Act shall not be advanced to the
12 agency. Memorandum of agreement (MOA) or other forms of
13 agreement the purpose of which is to obligate and
14 disburse to the agency any amounts from the sum
15 appropriated herein, including reimbursements for
16 payments is prohibited. All funds appropriated by this
17 Act shall be maintained under the authority of the
18 Director of the Office of Administrative Services.

1 Section 3. Allotment and Management of Funds, and
2 Lapse Date.

3 (1) The sum appropriated by this Act shall be
4 allotted to the Governor.

5 (2) The Governor shall be responsible for
6 ensuring these funds are used only for the purpose
7 specified under Section 1 of this Act. The sum
8 appropriated by this Act shall be administered in
9 accordance with the provisions of applicable law,
10 including, but not limited to, the State Financial
11 Management Act of 1983 and the State Contracts Act. The
12 authority to obligate the funds appropriated by this Act
13 shall lapse as of September 30, 2026. Any part of this
14 appropriation not obligated as of September 30, 2026
15 shall revert to the Special Revenue Fund of the State of
16 Yap.

17 Section 4. Reports. The Governor shall submit to
18 the Legislature the performance and financial quarterly
19 reports for each of the quarters in each fiscal year no
20 later than twenty days after the end of each quarter.
21 Each quarterly report shall include, but not limited to,
22 complete descriptions of the obligations incurred against

1 the funds appropriated by this Act, and the status of
2 the Funds as of the end of the completed quarter.

3 Section 5. This Act shall take effect upon the
4 approval by the Governor, or upon its becoming law
5 without such approval.
