

AN ACT

To appropriate the sum of \$638,778 from the Special Revenue Fund of the State of Yap for the purpose of appropriating U.S. Federal grant funds awarded for Waab Community Health Center with the Department of Health Services during Calendar Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$638,778, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to fund operations of Waab Community
5 Health Center with the Department of Health Services
6 during Calendar Year 2026.

7 Section 2. Conditions and Restrictions.

8 (1) Funds appropriated by this Act shall not be
9 available for obligation for their planned uses by the
10 agency until the respective grant cash amounts have been
11 drawn down by the State and are deposited in their
12 respective State accounts and available for disbursement.

13 (2) The sum appropriated by this Act shall not
14 be advanced to the agency. Memorandum of agreement (MOA)
15 or other forms of agreement the purpose of which is to
16 obligate and disburse to the agency any amounts from the
17 sum appropriated herein, including reimbursements for
18 payments is prohibited.

1 (3) All funds appropriated by this Act shall
2 be maintained under the authority of the Director of the
3 Office of Administrative Services.

4 Section 3. Allotment and Management of Funds, and
5 Lapse Date. The sum appropriated by this Act shall be
6 allotted to the Governor who shall be responsible for
7 ensuring these funds are used only for the purposes
8 specified under Section 1 of this Act. The sum
9 appropriated by this Act shall be administered in
10 accordance with the provisions of applicable law,
11 including, but not limited to, the State Financial
12 Management Act of 1983 and the State Contracts Act. The
13 authority to obligate the funds appropriated by this Act
14 shall lapse as of December 31, 2026, and any part of this
15 appropriation not obligated as of December 31, 2026 shall
16 revert to the Special Revenue Fund of the State of Yap.

17 Section 4. Reports. The Governor shall submit to
18 the Legislature the performance and financial quarterly
19 reports for each quarter in each fiscal year no later
20 than twenty days after the end of each quarter. Each
21 quarterly report shall include, but not limited to,
22 complete descriptions of the obligations incurred against

1 the funds appropriated by this Act, and the status of
2 the funds as of the end of the completed quarter.

3 Section 5. This Act shall take effect upon its
4 approval by the Governor, or upon its becoming law
5 without such approval.




