

AN ACT

To appropriate the sum of \$64,700 from the Special Revenue Fund of the State of Yap for the purpose of funding the public health programs in the Department of Health Services starting Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$64,700, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to fund programs in the Division of
5 Public Health, Department of Health Services starting
6 Fiscal Year 2026. The sum shall be apportioned in
7 accordance with the following schedule:

- 8 (1) FY2026 Yap State Opiod
9 Response (SOR)..... \$ 32,500; and
10 (Grant No. 6 H79TI087919-02)
11 (2) FY2026 SPF_PFS Yap..... \$ 32,200.
12 (Grant No. 5 H79SP083696-03)

13 Section 2. Conditions and Restrictions.

14 (1) Funds appropriated by this Act shall not be
15 available for obligation for their planned uses by the
16 agency until the respective grant cash amounts have been
17 drawn down by the State and are deposited in their

1 respective State accounts and available for disbursement.

2 (2) The sum appropriated by this Act shall not
3 be advanced to the agency. Memorandum of agreement (MOA)
4 or other forms of agreement the purpose of which is to
5 obligate and disburse to the agency any amounts from the
6 sum appropriated herein, including reimbursements for
7 payments is prohibited.

8 (3) All funds appropriated by this Act shall
9 be maintained under the authority of the Director of the
10 Office of Administrative Services.

11 Section 3. Allotment and Management of Funds, and
12 Lapse Date. The sum appropriated by this Act shall be
13 allotted to the Governor who shall be responsible for
14 ensuring these funds are used only for the purposes
15 specified under Section 1 of this Act. The sum
16 appropriated by this Act shall be administered in
17 accordance with the provisions of applicable law,
18 including, but not limited to, the State Financial
19 Management Act of 1983 and the State Contracts Act. The
20 authority to obligate the funds appropriated by this Act
21 shall lapse as of September 29, 2026, and any part of
22 this appropriation not obligated as of

1 September 29, 2026 shall revert to the Special Revenue
2 Fund of the State of Yap.

3 Section 4. Reports. The Governor shall submit to
4 the Legislature the performance and financial quarterly
5 reports for each quarter in each fiscal year no later
6 than twenty days after the end of each quarter. Each
7 quarterly report shall include, but not limited to,
8 complete descriptions of the obligations incurred against
9 the funds appropriated by this Act, and the status of
10 the Funds as of the end of the completed quarter.

11 Section 5. This Act shall take effect upon the
12 approval by the Governor, or upon its becoming law
13 without such approval.


