

AN ACT

To appropriate the sum of \$1,452,609.60 from the General Fund of the State of Yap for the purpose of funding the purchase of government equipment during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$1,452,609.60 or so much
2 thereof as may be necessary, is hereby appropriated from
3 the General Fund of the State of Yap for the purpose of
4 providing funding to fund the purchase of government
5 equipment during Fiscal Year 2026. The sum shall be
6 apportioned in accordance with the following schedule:

7 (1) Yap State Seaport Equipment.....\$ 1,452,609.60.

8 (a) Reach Stacker Container

9 Handler..... \$ 1,144,000;

10 (b) Shipping and Insurance

11 Cost \$ 197,740;

12 (c) Custom & Tax\$ 53,669.60;

13 and

14 (d) Contingency 5% \$ 57,200.

15 Section 2. Conditions and Restrictions.

16 (1) The sum appropriated by this Act shall not be
17 advanced to the agency. Memorandum of Agreement (MOA) or
18 other forms of agreement the purpose of which is to

1 obligate and disburse to the agency any amounts from the
2 sum appropriated herein, including reimbursement of
3 payments is prohibited.

4 (2) All funds appropriated by this Act shall be
5 maintained under the authority of the Director of
6 Administrative Services.

7 (3) Funds appropriated by this Act shall not be
8 reprogrammed for any other uses other than what is
9 specified under Section 1 of this Act.

10 Section 3. Allotment and Management of Funds, and
11 Lapse Date. The sum appropriated by this Act shall be
12 allotted to the Governor or designee who shall be
13 responsible for ensuring these funds are used only for
14 the purposes specified under Section 1 of this Act. The
15 sum appropriated by this Act be administered in
16 accordance with the provisions of applicable law,
17 including, but not limited to, the State Financial
18 Management Act of 1983 and the State Contracts Act. The
19 authority to obligate the funds appropriated by this Act
20 shall lapse as of September 30, 2026, and any part of
21 this appropriation not obligated as of September 30,
22 2026 shall revert to the General Fund of the State of

1 Yap.

2 Section 4. Reports. The Governor shall submit to the
3 Legislature the performance and financial quarterly
4 reports for each quarter in each fiscal year no later
5 than twenty days after the end of each quarter. Each
6 quarterly report shall include, but not limited to,
7 complete descriptions of the obligations incurred against
8 the funds appropriated by this Act, and the status of
9 the Funds as of the end of the completed quarter.

10 Section 5. This Act shall take effect upon the
11 approval by the Governor, or upon its becoming law
12 without such approval.


