

AN ACT

To appropriate \$48,336 from the General Fund of the State of Yap for the purpose of providing supplemental funding to fund Micronesian Legal Services Corporation - Yap Office during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$48,336, or so much thereof  
2           as may be necessary, is hereby appropriated from the  
3           General Fund of the State of Yap for the purpose of  
4           providing supplemental funding to fund the Micronesian  
5           Legal Services Corporation - Yap Office during Fiscal  
6           Year 2026. The funds would be in the form of a grant to  
7           the Corporation.

8           Section 2. Conditions and Restrictions.

9                   (2) All funds appropriated by this Act shall be  
10           maintained under the authority of the Director of the  
11           Office of Administrative Services.

12                   (3) The Director shall ensure funds are  
13           disbursed as a grant in the form prescribed and approved  
14           for such purposes.

15           Section 3. Allotment and Management of Funds, and  
16           Lapse Date.

17                   (1) The sum appropriated by this Act shall be  
18           allotted to the Governor, or his designee.

1           (2) The Governor shall be responsible for  
2 ensuring these funds are used only for the purpose  
3 specified under Section 1 of this Act. The sum  
4 appropriated by this Act shall be administered in  
5 accordance with the provisions of applicable law,  
6 including, but not limited to, the State Financial  
7 Management Act of 1983 and the State Contracts Act. The  
8 authority to obligate the funds appropriated by this Act  
9 shall lapse as of September 30, 2026. Any part of the  
10 funds appropriated by this Act not obligated by September  
11 30, 2026 shall revert to the General Fund of the State of  
12 Yap.

13           Section 4. Reports. The Governor shall submit to  
14 the Legislature the performance and financial quarterly  
15 reports for each of the quarters in each fiscal year no  
16 later than twenty days after the end of each quarter.  
17 Each quarterly report shall include, but not limited to,  
18 complete descriptions of the obligations incurred against  
19 the funds appropriated by this Act, and the status of  
20 the funds as of the end of the completed quarter.

21           Section 2. This Act shall take effect upon the  
22 approval by the Governor, or upon its becoming law
