

AN ACT

To appropriate the sum of \$6,438 previously appropriated by Yap State Law No. 11-114, from the Infrastructure Maintenance Fund (IMF) in the Special Revenue Fund of the State of Yap, for the purpose of providing remaining funding for Yap State Legislature Electrical Overhaul Project during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$6,438, or so much thereof as
2 may be necessary, is hereby appropriated from the Special
3 Revenue Fund of the State of Yap, from the remaining
4 balance of funds previously appropriated in Yap State Law
5 No. 11-114, to providing funding to complete the Yap
6 Legislature Electrical Overhaul Project during Fiscal
7 Year 2026.

8 Section 2. Conditions and Restrictions.

9 (1) Funds appropriated by this Act shall not be
10 available for obligation for their planned uses by the
11 agency until the respective grant cash amounts have been
12 drawn down by the State and are deposited in their
13 respective State accounts and available for disbursement.

14 (2) The sum appropriated by this Act shall not
15 be advanced to the agency. Memorandum of agreement (MOA)
16 or other forms of agreement the purpose of which is to
17 obligate and disburse to the agency any amounts from the
18 sum appropriated herein, including reimbursements for

1 payments is prohibited.

2 (3) All funds appropriated by this Act shall
3 be maintained under the authority of the Director of the
4 Office of Administrative Services.

5 Section 3. Allotment and Management of Funds, and
6 Lapse Date.

7 (1) The sum appropriated by this Act shall be
8 allotted to the Governor, or his designee.

9 (2) The Governor shall be responsible for
10 ensuring these funds are used only for the purpose
11 specified under Section 1 of this Act. The sum
12 appropriated by this Act shall be administered in
13 accordance with the provisions of applicable law,
14 including, but not limited to, the State Financial
15 Management Act of 1983 and the State Contracts Act. The
16 authority to obligate the funds appropriated by this Act
17 shall lapse as of September 30, 2026. Any part of the
18 funds appropriated by this Act not obligated by September
19 30, 2026 shall revert to the Special Revenue Fund of the
20 State of Yap.

21 Section 4. Reports. The Governor shall submit to
22 the Legislature the performance and financial quarterly
23 reports for each of the quarters in each fiscal year no
24 later than twenty days after the end of each quarter.

1 Each quarterly report shall include, but not limited to,
2 complete descriptions of the obligations incurred against
3 the funds appropriated by this Act, and the status of
4 the funds as of the end of the completed quarter.


5 Section 5. This Act shall take effect upon the
6 approval by the Governor, or upon its becoming law
7 without such approval.
