

AN ACT

To amend Yap State Law No. 11-151, by amending the Title and Section 1 to further appropriate the additional sum of \$131,887 from the Special Revenue Fund of the State of Yap for the purpose of providing further funding to Special Education program operations in the Department of Education during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-151 is
2 hereby amended to read as follows:

3 “To appropriate the sum of \$723,761.24 from the
4 Special Revenue Fund of the State of Yap for the
5 purpose of appropriating U.S. Federal grant funds
6 awarded for Special Education Program in the
7 Department of Education during Fiscal Year 2026,
8 and for other purposes.”

9 Section 2. Section 1 of Yap State Law No. 11-151 is
10 hereby amended to read as follows:

11 “Section 1. The sum of \$723,761.24, or so much
12 thereof as may be necessary, is hereby appropriated from
13 the Special Revenue Fund of the State of Yap for the
14 purpose of providing funding to fund Special Education
15 Programs in the Department of Education during Fiscal
16 Year 2026. The sum appropriated shall be deemed from the

1 United States Federal Grants identified as Grant Nos.
2 H027A240005-23A and H027A240005-24A, issued under Advice
3 of Allotment Nos. 520Y25023, 520Y25029, and 520Y26003 and
4 the balance of funds previously appropriated under Yap
5 State Law Nos. 11-100 and 11-111.”

6 Section 3. Section 3 of Yap State Law No. 11-151 is
7 hereby amended to read as follows:


8 “Section 3. Allotment and Management of Funds, and
9 Lapse Date. The sum appropriated by this Act shall be
10 allotted to the Governor who shall be responsible
11 for ensuring these funds are used only for the purposes
12 specified under Section 1 of this Act. The sum
13 appropriated by this Act shall be administered in
14 accordance with the provisions of applicable law,
15 including, but not limited to, the State Financial
16 Management Act of 1983 and the State Contracts Act. The
17 authority to obligate the funds appropriated by this Act
18 shall lapse as of September 30, 2026, and any part of
19 this appropriation not obligated as of September 30, 2026
20 shall revert to the Special Revenue Fund of the State of
21 Yap.”

22 Section 4. This Act shall take effect upon the


1 approval by the Governor, or upon its becoming law
2 without such approval.
