

AN ACT

To further amend Yap State Law No. 11-130, as amended, by amending the Title and Section 1, as amended by Yap State Law Nos. 11-147, 11-157 and 11-173, to appropriate the additional sum of \$205,762 from the Yap State Fiscal Year 2026 financial estimates in General Fund for the purpose of providing supplemental funding for government operations and programs during Fiscal Year 2026, by amending Section 2 for the purpose of approving reprogramming of funds, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-130,
2 as amended by Yap State Law Nos. 11-147, 11-157 and 11-
3 173, is hereby amended to read as follows:

4 “To appropriate the sum of \$12,316,349 from the Yap
5 State Fiscal Year 2026 financial estimates in the
6 General Fund for the purpose of funding government
7 operations, programs and projects in the State of
8 Yap during Fiscal Year 2026, and for other
9 purposes.”

10 Section 2. Section 1 of Yap State Law No. 11-130,
11 as amended by Yap State Law Nos. 11-147, 11-157 and 11-
12 173, is hereby amended to read as follows:

13 “Section 1. Operations, Programs and
14 Projects. The sum of \$12,316,349, or so much
15 thereof as may be necessary, is hereby appropriated
16 from the General Fund for the purpose of funding

1 government operations, programs and projects during
2 Fiscal Year 2026. The sum appropriated shall be
3 from Local Revenues for \$10,571,142 from Program
4 Income for \$816,044, from Airport and Airway
5 Operation and Maintenance Fund for \$129,165, and
6 from the General Fund Tobacco Tax Fund for
7 \$800,000; and shall be apportioned in accordance
8 with the following schedule:

16 Section 3. Section 2 of Yap State Law No. 11-130 is
17 hereby amended to read as follows:

18 "Section 2. Conditions and Restrictions.

19 (1) Funds herein appropriated under the Amended
20 Compact shall not be available for obligation for their
21 planned uses by the respective agencies until the
22 respective grants have been awarded and the respective

1 cash amounts have been drawn down by the State and are
2 deposited in their respective State accounts and
3 available for disbursement.

4 (2) Lump-sum budget amounts shall not be
5 advanced to any agency at the beginning of the fiscal
6 year, with exception to this provision as herein
7 specified. Memorandum of agreement (MOA) or other forms
8 of agreement the purpose of which is to obligate and
9 disburse to a respective agency its annual budget as
10 approved herein, including reimbursements to such
11 agencies for payments for expenditures under their
12 respective budget, is prohibited. All funds appropriated
13 by this Act shall be maintained under the authority of
14 the Director of the Office of Administrative Services;
15 PROVIDED the Director may advance to such agencies
16 specified and established by statute with financial
17 authority to administer and manage funds in accordance
18 with applicable laws, and are further required to report
19 to the Director on status of funds:

20 (a) Yap Visitors' Bureau.

21 (3) Funds herein appropriated shall be allotted
22 only on a quarterly basis, except where it is essential

1 for the effective and efficient performance of the duties
2 and responsibilities of an agency to allot certain lump-
3 sum amounts at the beginning of the fiscal year such as
4 for the purchase of fixed assets and for contractual
5 services. The funds appropriated herein for Yap Day
6 Celebration shall not be allotted until January 31, 2026
7 and only upon a showing to the Governor that the plans,
8 specific budget and program are complete.

9 (4) Funds appropriated herein for personnel
10 shall not be reprogrammed for other uses; EXCEPT for the
11 following:

12 (a) Department of Youth and Civic Affairs
13 is authorized to reprogram \$8,837 into Consumables;
14 and

15 (b) Yap Visitors' Bureau is authorized to
16 reprogram \$16,532 into Contractual Services.

17 (c) Department of Health Services is
18 authorized to reprogram \$20,000 for other health
19 needs.

20 (5) Funding for fixed asset may only be
21 reprogrammed after July 31, 2026.

22 Section 4. The additional sum of \$205,762

1 appropriated by this Act shall not be reprogrammed.”


2 Section 5. This Act shall take effect upon the
3 approval by the Governor, or upon its becoming law
4 without such approval.




