FOURTH REGULAR SESSION, 2026

A RESOLUTION

Approving \$14,592,880, subject to Yap State appropriation law, the Yap State Fiscal Year 2027 recommended budget estimates for funding under the 2023 Amended Compact for submission to the President of the Federated States of Micronesia to transmit to the United States for review and approval.

1 BE IT RESOLVED by the Eleventh Legislature of the
2 State of Yap, Fourth Regular Session, 2026 that the
3 Legislature hereby approves \$14,592,880, subject to Yap
4 State appropriation law, the Yap State Fiscal Year 2027
5 recommended budget estimates for funding under the 2023
6 Amended Compact for submission to the President of the
7 Federated States of Micronesia to transmit to the United
8 States for review and approval; and

9 BE IT FURTHER RESOLVED the \$14,592,880 breakdown by
10 sources are as follows:

- 11 1. Education sector \$ 7,345,598,
- 12 2. Health Sector \$ 6,369,540,
- 13 3. Private Sector \$ 122,656,
- 14 4. Environment Sector \$ 27,579,
- 15 5. Public Sector \$ 285,183,
- 16 6. Enhanced Rep.& Accty \$ 442,323;

17 BE IT FURTHER RESOLVED that the Governor shall timely
18 inform the Legislature of the 2023 Amended Compact sector

1 grant awards for funding the Fiscal Year 2027 Budget, and
2 to provide all pertinent information such as specific
3 changes made by the United States to the budget details as
4 recommended by the Legislature, and any condition which
5 the United States may have imposed on any planned uses of
6 the grants awarded for Yap State; and

7 BE IT FURTHER RESOLVED that the Legislature endorses
8 and approves the Yap State Project Management Office
9 operation budget of \$723,219 for Fiscal Year 2027, subject
10 to Congressional appropriation; and

11 BE IT FURTHER RESOLVED that the Legislature endorses
12 and approves the \$350,105 request for Terminal Warehouse
13 Phase 2 Renovation Project from Yap State's share of the
14 Infrastructure Maintenance Fund in the 3rd Amended Compact,
15 subject to Congressional appropriation; and

16 BE IT FURTHER RESOLVED that certified copies of this
17 Resolution be transmitted to the Governor, the President
18 of the Federated States of Micronesia, the Speaker of the
19 Congress of the Federated States of Micronesia, the
20 Chairman of the Yap Congressional Delegation, the Director
21 of the Office of Planning and Budget, the Director of the
22 Office of Administrative Services, the Chief of Budget,

1 the Director of Public Works and Transportation, the
2 Chairman of the Council of Pilung and the Chairman of the
3 Council of Tamol.


