Bill No. 11-128

A BILL FOR AN ACT

To appropriate the sum of \$28,101 from the General Fund of the State of Yap for the purpose of providing funding to fund the Special Election in Election District No. 3 during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1           Section 1. The sum of \$28,101, or so much thereof as may  
2 be necessary, is hereby appropriated from the General Fund of  
3 the State of Yap for the purpose of providing funding to fund  
4 the Special Election in Election District No. 3 scheduled for  
5 May 15, 2025 and as prescribed by the call for a Special  
6 Election issued on February 3, 2025.

7           Section 2. Conditions and Restrictions.

8           (1) The sums appropriated by this Act shall not be  
9 advanced to any agency. Memorandum of agreement (MOA) or other  
10 forms of agreement the purpose of which is to obligate and  
11 disburse to the agency any amounts from the sum appropriated  
12 herein, including reimbursements for payments is prohibited.

13           (2) All funds appropriated by this Act shall be  
14 maintained under the authority of the Director of the Office of  
15 Administrative Services.

16           Section 3. Allotment and Management of Funds, and  
17 Lapse Date.

18           (1) The sum appropriated in Section 1 of this Act

1 shall be allotted to the Governor.


2 (2) The allottee shall be responsible for ensuring  
3 these funds are used only for the purpose specified under  
4 Section 1 of this Act. The sum appropriated by this Act shall  
5 be administered in accordance with the provisions of applicable  
6 law, including, but not limited to, the State Financial  
7 Management Act of 1983 and the State Contracts Act. The  
8 authority to obligate the funds appropriated by this Act shall  
9 lapse as of September 30, 2025. Any part of this appropriation  
10 not obligated as of September 30, 2025 shall revert to the  
11 General Fund of the State of Yap.

12 Section 4. Reports. The allottee shall submit to the  
13 Legislature the performance and financial quarterly reports for  
14 each of the quarters in each fiscal year no later than twenty  
15 days after the end of each quarter. Each quarterly report shall  
16 include, but not limited to, complete descriptions of the  
17 obligations incurred against the funds appropriated by this Act,  
18 and the status of the Funds as of the end of the completed  
19 quarter.

20 Section 5. This Act shall take effect upon the approval by  
21 the Governor, or upon its becoming law without such approval.
