A BILL FOR AN ACT

To further amend Yap State Law No. 11-29, as amended by Yap State Law No. 11-102, by amending the Title and Section 1 to appropriate an additional sum of \$48,400 from the Special Revenue Fund of the State of Yap for the Pediatric Mental Health Care Access (PMHCA) program in the Department of Health Services during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-29, as
2 amended by Yap State Law No. 11-102, is hereby further amended
3 to read as follows:

4 “To appropriate the sum of ~~\$266/238~~314,638 from the
5 Special Revenue Fund of the State of Yap for the purpose of
6 appropriating U.S. Federal grant funds awarded for Department
7 of Health programs during Fiscal Year 2025~~6~~, and for other
8 purposes.”

9 Section 2. Section 1 of Yap State Law No. 11-29, as
10 amended by Yap State Law No. 11-102, is hereby further amended
11 to read as follows:

12 “Section 1. The sum of ~~\$266/238~~314,638, or so much
13 thereof as may be necessary, is hereby appropriated from the
14 Special Revenue Fund of the State of Yap for the purpose of
15 providing funding to fund Department of Health Services
16 programs during Fiscal Year 2025~~6~~. The sum appropriated shall

be deemed from United States Federal Grants awarded for health programs as follows:

(\$74,500 from Grant No. 4 U4AMC45816-01-02, expiring September 29, 2026 and \$18,400 from Grant No. 04 U4AMC53364-01-03,

expiring September 29, 2026)

(6) FY2024 Mother & Child Health (MCH)..... \$ 61,317.

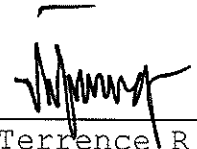

Section 3. This Act shall take effect upon its approval
by the Governor, or upon its becoming law without such
approval.
