

AN ACT

To appropriate the sum of \$130,248.59 from the Infrastructure Maintenance Fund (IMF) of the State of Yap for the purpose of providing funding for the Satawal Community Building Renovations Project during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$130,248.59, or so much
2 thereof as may be necessary, is hereby appropriated from
3 the Infrastructure Maintenance Fund (IMF) of the State of
4 Yap, to providing funding the renovations on the Satawal
5 Community Building during Fiscal Year 2026.

6 Section 2. Conditions and Restrictions.

7 (1) Funds appropriated by this Act shall not be
8 available for obligation for their planned uses by the
9 agency until the respective grant cash amounts have been
10 drawn down by the State and are deposited in their
11 respective State accounts and available for disbursement.

12 (2) The sum appropriated by this Act shall not
13 be advanced to the agency. Memorandum of agreement (MOA)
14 or other forms of agreement the purpose of which is to
15 obligate and disburse to the agency any amounts from the
16 sum appropriated herein, including reimbursements for
17 payments is prohibited.

18 (3) All funds appropriated by this Act shall

1 be maintained under the authority of the Director of the
2 Office of Administrative Services.

3 Section 3. Allotment and Management of Funds, and
4 Lapse Date.

5 (1) The sum appropriated by this Act shall be
6 allotted to the Governor, or his designee.

7 (2) The Governor shall be responsible for
8 ensuring these funds are used only for the purpose
9 specified under Section 1 of this Act. The sum
10 appropriated by this Act shall be administered in
11 accordance with the provisions of applicable law,
12 including, but not limited to, the State Financial
13 Management Act of 1983 and the State Contracts Act. The
14 authority to obligate the funds appropriated by this Act
15 shall lapse as of September 30, 2026. Any part of the
16 funds appropriated by this Act not obligated by September
17 30, 2026 shall revert to the Special Revenue Fund of the
18 State of Yap.

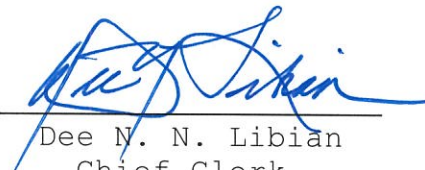
19 Section 4. Reports. The Governor shall submit to
20 the Legislature the performance and financial quarterly
21 reports for each of the quarters in each fiscal year no
22 later than twenty days after the end of each quarter.

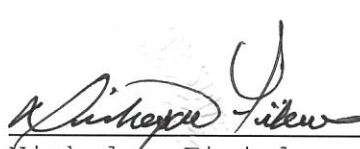
1 Each quarterly report shall include, but not limited to,
2 complete descriptions of the obligations incurred against
3 the funds appropriated by this Act, and the status of
4 the funds as of the end of the completed quarter.

5 Section 5. This Act shall take effect upon the
6 approval by the Governor, or upon its becoming law
7 without such approval.
