

AN ACT

To appropriate the sum of \$17,500 from the Special Revenue Fund of the State of Yap for the purpose of appropriating SPREP grant funds awarded for the Division of Agriculture and Forestry in the Department of Resources and Development during Fiscal Year 2025, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The sum of \$17,500, or so much thereof
2 as may be necessary, is hereby appropriated from the
3 Special Revenue Fund of the State of Yap for the purpose
4 of providing funding to fund the African Tulip Project
5 with the Division of Agriculture and Forestry in the
6 Department of Resources and Development during Fiscal
7 Year 2025. The letter of agreement governing the terms of
8 the grant is referenced as AP 2/18/18/1.

9 Section 2. Conditions and Restrictions.

10 (1) Funds appropriated by this Act shall not be
11 available for obligation for their planned uses by the
12 agency until the respective grant cash amounts have been
13 drawn down by the State and are deposited in their
14 respective State accounts and available for disbursement.

15 (2) The sum appropriated by this Act shall not
16 be advanced to the agency. Memorandum of agreement (MOA)
17 or other forms of agreement the purpose of which is to
18 obligate and disburse to the agency any amounts from the

1 sum appropriated herein, including reimbursements for
2 payments is prohibited.

3 (3) All funds appropriated by this Act shall
4 be maintained under the authority of the Director of the
5 Office of Administrative Services.

6 Section 3. Allotment and Management of Funds, and
7 Lapse Date. The sum appropriated by this Act shall be
8 allotted to the Governor who shall be responsible
9 for ensuring these funds are used only for the purposes
10 specified under Section 1 of this Act. The sum
11 appropriated by this Act shall be administered in
12 accordance with the provisions of applicable law,
13 including, but not limited to, the State Financial
14 Management Act of 1983 and the State Contracts Act. The
15 authority to obligate the funds appropriated by this Act
16 shall lapse as of June 13, 2026, and any part of this
17 appropriation not obligated as of June 13, 2026 shall
18 revert to the Special Revenue Fund of the State of Yap.

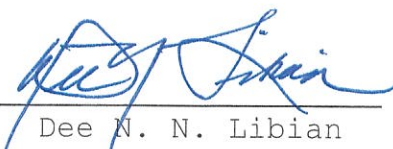
19 Section 4. Reports. The Governor shall submit to
20 the Legislature the performance and financial quarterly
21 reports for each quarter in each fiscal year no later
22 than twenty days after the end of each quarter. Each

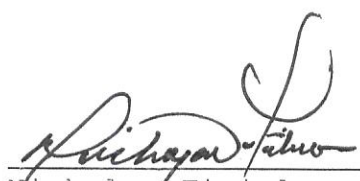
1 quarterly report shall include, but not limited to,
2 complete descriptions of the obligations incurred against
3 the funds appropriated by this Act, and the status of
4 the Funds as of the end of the completed quarter.

5 Section 5. This Act shall take effect upon its
6 approval by the Governor, or upon its becoming law
7 without such approval.

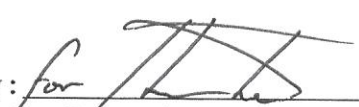
