YAP STATE LAW NO. 11-156

THIRD REGULAR SESSION, 2025

AN ACT

To further amend Yap State Law No. 11-29, as amended by Yap State Law No. 11-102, by amending the Title and Section 1 to appropriate an additional sum of \$48,400 from the Special Revenue Fund of the State of Yap for the Pediatric Mental Health Care Access (PMHCA) program in the Department of Health Services during Fiscal Year 2026, and for other purposes.

Be it enacted by the Legislature of the State of Yap.

1 Section 1. The Title of Yap State Law No. 11-29, as
2 amended by Yap State Law No. 11-102, is hereby further
3 amended to read as follows:

4 “To appropriate the sum of \$314,638 from the Special
5 Revenue Fund of the State of Yap for the purpose of
6 appropriating U.S. Federal grant funds awarded for
7 Department of Health programs during Fiscal Year 2026,
8 and for other purposes.”

9 Section 2. Section 1 of Yap State Law No. 11-29, as
10 amended by Yap State Law No. 11-102, is hereby further
11 amended to read as follows:

12 “Section 1. The sum of \$314,638, or so much thereof
13 as may be necessary, is hereby appropriated from the
14 Special Revenue Fund of the State of Yap for the purpose
15 of providing funding to fund Department of Health
16 Services programs during Fiscal Year 2026. The sum

1 appropriated shall be deemed from United States Federal
2 Grants awarded for health programs as follows:

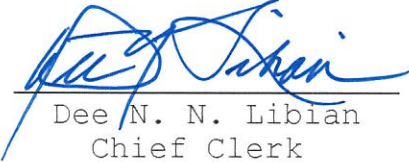

Section 3. This Act shall take effect upon its approval by the Governor, or upon its becoming law without such approval.
