

A RESOLUTION

Approving \$14,486,720, subject to Yap State appropriation law, the Yap State Fiscal Year 2026 recommended budget estimates for funding under the 2023 Amended Compact for submission to the President of the Federated States of Micronesia to transmit to the United States for review and approval.

1 BE IT RESOLVED by the Eleventh Legislature of the
2 State of Yap, Third Regular Session, 2025 that the
3 Legislature hereby approves \$14,486,720, subject to Yap
4 State appropriation law, the Yap State Fiscal Year 2026
5 recommended budget estimates for funding under the 2023
6 Amended Compact for submission to the President of the
7 Federated States of Micronesia to transmit to the United
8 States for review and approval; and

9 BE IT FURTHER RESOLVED the \$14,486,720 breakdown by
10 sources are as follows:

- 11 1. Education sector \$ 7,344,594,
- 12 2. Health Sector \$ 6,476,841,
- 13 3. Public Sector \$ 268,409, and
- 14 5. Enhanced Rep.& Accty .. \$ 396,876; and

15 BE IT FURTHER RESOLVED that the Governor shall timely
16 inform the Legislature of the 2023 Amended Compact sector
17 grant awards for funding the Fiscal Year 2026 Budget, and
18 to provide all pertinent information such as specific

1 changes made by the United States to the budget details as
2 recommended by the Legislature, and any condition which
3 the United States may have imposed on any planned uses of
4 the grants awarded for Yap State; and

5 BE IT FURTHER RESOLVED that the Legislature endorses
6 and approves the Yap State Project Management Office
7 operation budget of \$723,219 for Fiscal Year 2026, subject
8 to Congressional appropriation; and

9 BE IT FURTHER RESOLVED that this Legislature endorses
10 application for \$1,998,979 to be drawn down from the FSM
11 Trust Fund, Account 3, for use by Yap State for the
12 purpose of funding purchase of needed port equipment; and

13 BE IT FURTHER RESOLVED that certified copies of this
14 Resolution be transmitted to the Governor, the President
15 of the Federated States of Micronesia, the Director of the
16 Office of Planning and Budget, the Director of the Office
17 of Administrative Services, the Chief of Budget, the
18 Chairman of the Council of Pilung and the Chairman of the
19 Council of Tamol.


